

#### 4 GERTRUDES WHO CHANGED THE WORLD

(All 4 excerpted from Mental\_Floss, March-April 2013)



Gertrude Stein, a Pennsylvania native, was in the vanguard of the avant-garde in the early 20th century. After moving to France at age 29, she began assembling one of the most important early collections of modern art. Many regard her tiny apartment as the world's first modern art museum. Not just a collec-

tor and admirer, her force of personality was instrumental in fanning the fledgling movement. She actually did too good of a job. As the prices of modern impressionist works rocketed, Stein could no longer afford to buy new

pieces. Her writings also played an important role in the modernist movement. A decade before James Joyce started writing *Ulysses*, Stein started the first major modern experimental novel in English. At 1,000 pages, *The Making of Americans: Being a History of a Family's Progress*, tells the story of a family without the use of plot, dialogue, or action. She wrote in longhand and never revised the work. It is often described as a literary companion to Cubism. Stein passed away from stomach cancer at 72 with her partner, Alice B. Toklas, by her side. Stein provided the fierce support the modernist art movement needed in its earliest stages. (When someone commented to Picasso that she didn't look like her portrait, he replied, "She will.")





Booklovers will recognize the second Gertrude—Gertrude Bell, Desert Queen, the woman responsible for drawing



the borders of Iraq. Born in 1868 to the sixth-richest family in England, Gertrude Bell displayed a fierce intelligence at a young age. At 17, she was one of the few women admitted to Oxford University. After graduating, she traveled the globe hunting adventure. She taught herself Persian and trekked through Iran; she picked up Arabic and surveyed the Arabian Desert by camel,

cultivating friendships with tribal leaders and kings. She acquired an extraordinary amount of rare and valuable knowledge. In 1917, she was installed in Baghdad under the British High Commissioner—a position that catapulted her into the task of nation-building. For a plucky women who'd breezed through challenges in conflict-ridden deserts, nation-building took its toll. Always an archaeologist at heart, Bell fought to keep Mesopotamian artifacts in Iraq instead of allowing them to be whisked off to foreign museums. In 1926, she opened the Baghdad Archaeological Museum That same year, she passed away at age 57. The Iraq boundaries Gertrude Bell created are still used to this day.

## WHAT MORE CAN WE DO TO HELP VICTIMS OF MILITARY SEXUAL HARRASSMENT? \*

"When someone in the military is injured on duty, they're a hero and people shake their heads. I was injured too, but I'm treated like it was my fault. I didn't join the military to get raped; I wanted to serve my country too, and I did for nearly two years," said Kori Cioca, the lead plaintiff of a class-action lawsuit against the military, and a subject in the award-winning, Oscar-nominated documentary entitled "The Invisible War."

A recent study by the Department of Veterans Affairs found that about half of women sent to Iraq or Afghanistan report being sexually harassed, and nearly one in four say they were sexually assaulted. Most incidents are never reported, partly because military personnel have to report to their chain of command and that could include the rapist or his friends.

Two years ago, through our Legal Advocacy Fund program, the AAUW began providing support to the original class action lawsuit and to two more class-action lawsuits against the military on behalf of female and male survivors of military sexual assault.

This month, the U.S. Commission on Civil Rights and Congress held separate hearings on military sexual assault. At the hearings, the military said they have instituted

many new training and prevention programs, but they do not want to change the reporting or prosecuting process, which means commanders continue to have all the power, even though they are not impartial judges, and they may even be the assailants. If survivors still face barriers to reporting, if alleged rapists likely face little punishment, and if commanders have so much power, what changes? How long will this continue? Our military members deserve so much better.

In November of 2011, Rep. Jackie Speier (D-CA) introduced the Sexual Assault Training Oversight and Prevention Act (STOP Act) to create an independent review process for rape reports. Members of our AAUW Branch can help by contacting our Congressional representatives and letting them know that we want them to act to change the military reporting structure. Specifically, please write to your Congressman and Senators and ask them to create a joint civil and military panel to review the complaints of military women who are alleging that they are or were victims of sexual assault. Ms. Kreal believes that a short, handwritten note will receive more attention than a petition, or typed letter. (See page 9 for a listing of Senators and Congressman representing Central Florida.)

Gertrude Chandler Warner: The Gertrude Who Made Boxcars Exciting

Our third Gertrude grew up across the street from the Putnam, CT, train station. She and her two siblings became fascinated by the bare-bones living quarters housed in cabooses.

In her sophomore year, Warner was forced to drop out of high school due to poor health, but when many teachers were called up during WWI, she was asked to teach first grade. Despite her lack of experience, she took to it well and taught for the next 32 years.

It was the combination of these three things—her train-filled childhood, her love of teaching, and her recurring health problems—that led to the creation of one of the most be-

loved series of children's books. The idea of the Boxcar Children came to her one day when she was home sick. Confined to bed, she decided to write a story to share with her students upon her return to class. She created a fictional world with young protagonists—four siblings who set up shop in a boxcar. What made these children's stories so unique was the elimination of parents and authority figures.

The first version of Warner's book was published by Rand McNally in 1924 as *The Box-Car Children*, but in 1942 another publisher released a simplified version of the text—aimed at poor readers and children learning English. The series took off. Today there are more than 150 Boxcar books, but only the first 19 were written by Warner herself. In 1979, she died in the same town where she'd grown up, unmarried, with no children. Her book series lived on, updated by a team of ghostwriters.

## GERTRUDE SIMMONS BONNIN The Gertrude who Fought the System



Zitkala-Ša (pronounced zitkála-ša, which translates to "Red Bird"), was also known by her missionary-given name, Gertrude Simmons Bonnin.

Our final Gertrude was born in 1876 (the year of the Battle of the Little Bighorn), to a full-blooded Sioux woman and a white man. At age 7 she was lured by Quaker missionaries to White's Manual

Labor Institute in Wabash, Indiana. It was there that her long braids were sliced off—and that she learned to write in English.

In 1899, after earning a scholarship to Earlham University in Indiana, where she studied violin, she then spent two years at the New England Conservatory. While in Boston she began to write stories and essays, using the pseudonym Zitkala-Ša. She accepted a position as a music teacher at Pennsylvania's Carlisle Indian Industrial School. (Among the contingent of Americans performing at the Paris Exposition in 1900 was Gertrude Simmons Bonnin. Bonnin performed as a violin soloist with the Carlisle Indian Band.)

But she was horrified by the institution's underlying philosophy—"Kill the Indian in him, and save the man." She began writing political essays criticizing the practices. Her writings led to a strained relationship with the assimilation schools that had taught her to write in the first place. Her stint at Carlisle didn't last.

She took a job as a clerk at the Bureau of Indian Affairs at

Standing Rock Indian Reservation in New Mexico where in 1902 she met and married a mixed-race Nakota man, Captain Raymond Bonnin. Soon after marrying, Bonnin was assigned to the Uintah-Ouray reservation in Utah, where the couple was to live and work with the Ute people for the next fourteen years. During this period Zitkala-Ša gave birth to the couple's only child, Ohiya.

She became secretary for the Society of American Indians and moved to Washington DC to lobby for the organization.

She persuaded the General Federation of Women's Clubs to establish an Indian Welfare Committee, and later co-wrote an investigation into the government's mistreatment of tribes. The group uncovered vast mismanagement within the Bureau of Indian Affairs as well as how corporations had been defrauding American Indians in Oklahoma to gain access to oil-rich lands. The reports also criticized the administration of the schools as "grossly inadequate." Children were being abused for refusing to pray in the Christian way and punished for clinging to their heritage. Ultimately, the investigations inspired new school legislation and helped to give land management rights back to American Indians.

Her lifework was dedicated to protecting and preserving native culture, while helping American Indians assimilate into the mainstream. But in all her activism, she never gave up music. She died in 1938 at the age of 61, the same year that her opera "Sun Dance" debuted on Broadway. The show, one of the first to spotlight American Indian themes, received critical acclaim. Although she wrote the libretto and songs, the publicity only mentioned William F. Hanson as composer. Today, she is buried at Arlington National Cemetery, alongside her military veteran husband.
