

But did you know that he was a friend of AAUW?

Between 1938-1942, over 140 German-speaking women, mostly Jewish academics and scientists, requested help from AAUW in Washington. Many were dismissed from their jobs, ostracized from their communities, denied their rights and faced persecution. In response to these pleas, AAUW created the War Relief Committee that aided over 100 women in safe relocations, finding them jobs and supporting their research through fellowships and grants. Einstein was also working to resettle Jewish women scientists fleeing from Nazi-controlled countries. The AAUW War Relief Committee found a good friend and ally in Einstein. AAUW Archives documents the organization's heroic efforts to help women in need and contains a letter signed by Albert Einstein requesting assistance for Marietta Blau, an Austrian physicist.

The efforts of AAUW and Einstein to save the lives and works of academics and scientists are amazing, just another inspiring example of AAUW's 131 yearold history of devotion to helping and empowering women in need. On March 14, remember to celebrate Einstein's birthday and honor him for his part in helping women and the AAUW War Relief Committee.



Did you know . . . ?

Church officials, not knowing whether St. Patrick was born on March 8 or 9, decided to honor him on March 17, the sum of the two dates. Shamrock is derived from the Irish word "seamrog" ("little clover") and was used for its medicinal properties.



Legal Advocacy Fund

D.C. Circuit Hears Arguments in Klay v. Panetta

On February 14, the U.S. Court of Appeals for the D.C. Circuit heard arguments in *Klay v. Panetta*, a Legal Advocacy Fund-supported lawsuit brought by survivors of military sexual assault and litigated by attorney Susan Burke. The case was originally filed March 6, 2012, and AAUW Executive Director Linda D. Hallman spoke at the accompanying National Press Club event.

In the suit, the *Klay* plaintiffs allege that U.S. military officials tolerated sexual predators in their ranks

and antagonized service members who reported rape, sexual assault, and harassment. The plaintiffs argue that this culture of sexual assault violates their constitutional rights. In early 2013, the U.S. District Court for the District of Columbia granted the defendants' motion to dismiss the case. The court held that the plaintiffs' injuries were "incident to their military service" and that the court was prevented by legal precedent from ruling on a military matter. Burke then appealed to the D.C. Circuit. Stay tuned for the appeals court's ruling.

One ancient Olympic event, the pankration, was a mix of boxing, wrestling, and endurance that had virtually no rules. During the pankration event in 564 B.C., Arrachion of Phigalia and his opponent both beat each other senseless, and Ar-



rachion was declared the winner. But Arrachion refused to stand and claim victory—because he was dead. Since the bout had already been decided, Arrachion became the only dead person in history to win an Olympic event.

Agnodice had to give the judge a glimpse of her own gyn, whereupon the plaintiffs did a catch-22, charging her with practicing a profession limited to men. Agnodice copped to the new charge and was acquitted. Athenians bit their lips and finally changed the law, opening the door to other female physicians.

- 92% of girls had no involvement with the criminal justice system within one year of leaving PACE.
- 2. 94% of girls improved academically while at PACE.
- 3. 93% of girls were in school, higher education, or employed after leaving PACE.

Now is the time for community support to stand behind PACE and the young ladies who need this program. MARK YOUR CALENDARS for WEDNES-DAY, APRIL 16, noon to 1 p.m., for PORTRAITS OF PACE, the annual luncheon.

This year I am making a plea in addition to your attendance.
