From the President



The political races on November 3 are not the only ones to be won in November. Since November 15, 1937, people have also celebrated Sadie Hawkins Day named after the character created by cartoonist Al Capp in the *Li'l Abner* comic strip (1934-1977). As the story lines goes, Sadie

Hawkins was the daughter of Hekzebiah Hawkins, one of Dogpatch's earliest settlers, and she was a homely gal. She grew tired of waiting for suitors until she reached age 35 when her father, in desperation, called together all the unmarried men of Dogpatch and declared it "Sadie Hawkins Day." In a feminist turnabout, of sorts, Sadie pursued the eligible bachelors in a foot race reversing the cultural role of men as the romantic pursuers. Matrimony was the consequence for Sadie literally catching a bachelor and thus demonstrating her determination and athletic prowess!

The storyline inspired a fad on college campuses, and in 1939, *Life* magazine reported that 201 colleges in 188 cities had Sadie Hawkins Day events. These events evolved away from footraces to dances where women ask men to dance and, by tradition, men cannot refuse. In the intervening years, and with the advent of changing cultural norms and patterns of courtship, Spinsters' Balls were relabeled Snow Balls. A more recent variant is 'speed dancing' in which a DJ picks two people to start dancing. The DJ periodically stops the song and each person must select another partner in a snowball effect that eventually involves most people at the dance. Sadie

Hawkins Day is celebrated in various forms in the US, Canada, some countries in South America and even in Australia. The date of Sadie Hawkins Day varies each year but is generally held on the first Saturday after November 11 although it will be on Friday, November 13 in 2020. Personally, I am hoping to engage in celebratory dancing after the November 3 race!

One final note: our Branch received a thank you card from Mr. Alex Agosto, Principal of Pine Crest Elementary School of Innovation, Sanford, FL, for the donation of 130 books arranged by our member Dr. Sherry Kragler. The books were a donation from the UCF Bookstore that were received last spring by our President.

October is a month of emerging urgencies. The sudden loss of Supreme Court Justice Ruth Bader Ginsburg and the swift response of Senate Republicans in a move to appoint an ultraconservative justice threatens AAUW's raison d'etre of ensuring gender equity. Most salient to me, as a former Executive Director of the Center for Women's Health at the University of Florida, is the loss of reproductive rights and a woman's right to choose. Approximately 25% of US women have chosen to terminate a pregnancy. In the last 3 years, state legislatures

have been emboldened to enact restrictions on access to women's reproductive healthcare, in general, and to add draconian measures such as disallowing abortion after 8 weeks of pregnancy in OH, MO, MI, GA, KY. The Senate has populated the federal courts with 200 Trumpapproved judges. The 200th judge called for "complete and immediate reversal" of *Roe v. Wade* (Kate Smith, CBS News, 6/25/20). Call our Senators and remind them of their arguments against an Obama appointment so close to the election. So far, the absence of integrity has been glaring.

[The following letter was written by Leslie and endorsed by the Board regarding the nomination of Judge Amy Coney Barrett to the Supreme Court. Although she has already been sworn in, the Officers and Appointed Chairs would like you to be aware of the position taken by the Board.]

Supreme Court nominee Judge Amy Coney Barrett has a record of legal decisions and writings that jeopardize the welfare of women in the workplace, in healthcare and in education. As members of the 170,000 strong American Association of University Women, we are concerned that the lifelong appointment of Judge Barrett will diminish or eradicate our achievements toward gender equity for women.

Judge Barrett has ruled in favor of companies practicing age and racial discrimination and not compensating workers for overtime. More troubling are her clear intentions to rule against the precedent-setting Roe v. Wade and the Affordable Care Act. She has signed two anti-abortion public notices, is a member of a University

of Notre Dame Faculty for Life group, has ruled in two cases restricting women's reproductive freedom and privacy, and has been critical of the Supreme Court's ruling upholding the Affordable Care Act.

One ruling undermines Title IX prohibiting sex discrimination by making it more difficult for female students to pursue cases of sexual harassment and assault in schools and colleges.

Therefore, we oppose her appointment, particularly at this time that neither allows adequate review of her three-year record as a judge with over 100 written opinions and dissents, greatly curtails the average 113 days between a Supreme Court vacancy and hearings, nor honors Justice Ruth Bader Ginsburg's legacy and last wishes. The Supreme Court belongs to the American people—not a political party—and we deserve an appointee committed to equal justice under the law.

PACE began the fall semester on September 14, 2020. Girls had been attending classes remotely all through the summer, and any girl who did not have a computer was giv-

en one so that she could keep up with her teachers and counsellors. In addition to the on-line

classes and counselling sessions, members of the PACE staff visited the girls throughout the summer to make sure they were doing as well as possible. For the fall, the girls were offered the choice of returning to in-person classes or continuing their remote learning. As of today, only about a quarter of the girls are actually in the school.

AAUW has been celebrating Thanksgiving with the girls at PACE for over 17 years. The sumptuous traditional Thanksgiving meals have been greatly enjoyed by the PACE girls as well as the AAUW women who provided the meals. But this year is different. At this time, most of the girls are learning remotely and no volunteers are allowed in the PACE building. Therefore, after consultation with the PACE staff, we are planning to provide gift cards for grocery stores to each girl. We are asking all members to send donations for this

Thanksgiving meal to Phyllis Hall (481 Forest Court, Altamonte Springs, 32714). Please mark it "for PACE Thanksgiving." Thank you for your generosity.

We are hoping and planning to continue to provide the Miracle Bags (Boxes) in December. The last couple of years Pace provided us a list of each girl's wishes which made for a wonderful experience for the girls and for us. More on this later.

The food pantry at PACE, begun by AAUW, has gotten depleted over the summer. If you can help, it would be greatly appreciated. There is a special need this year for bottled water as health requirements prohibit the use of the water fountains. Donations can be dropped off at PACE or at the home of one our members who will take things to PACE if that is more convenient for you. The quilt above was made by Phyllis at the request of a young friend as a Christmas gift for her musician husband.






Hanna's quarantine project


